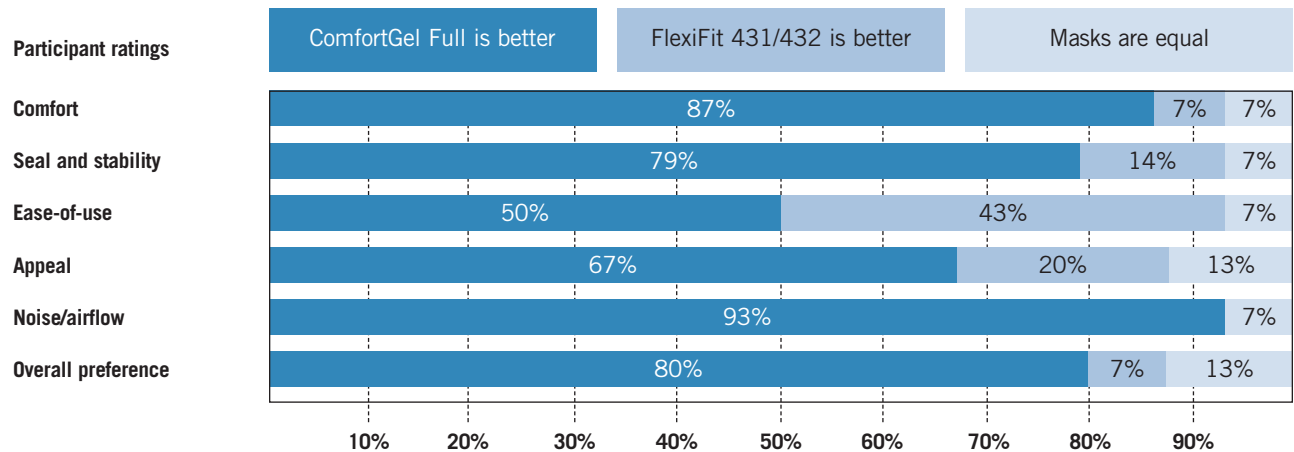

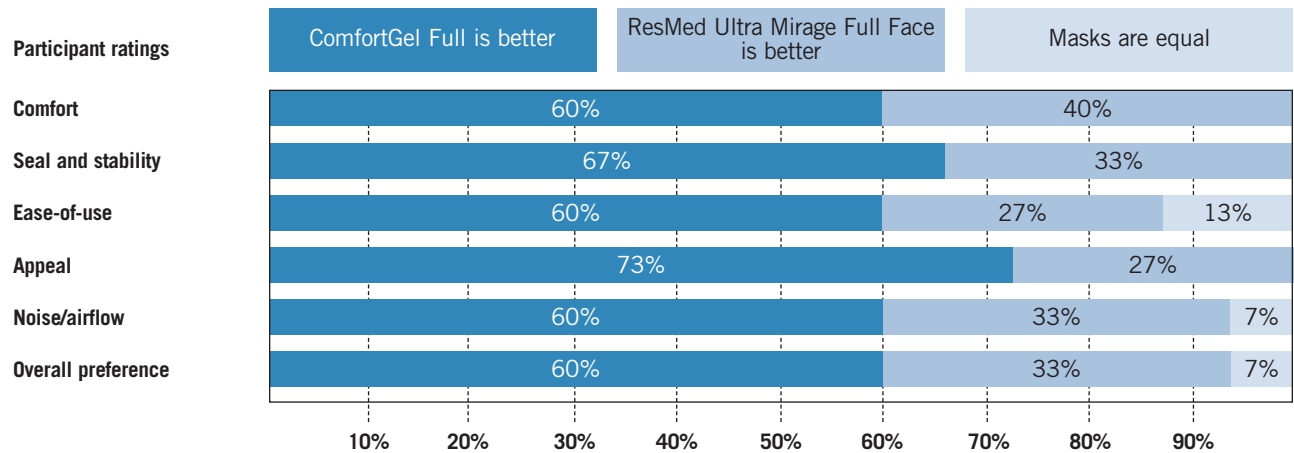
ComfortGel Full Preferred
